TERMS AND CONDITIONS

- 1. Terms of this auction are CASH or CHECK.
- 2. All buyers must register at sale office for proper recognition.
- If you would like to support the Youth but do not wish to keep the animal, there are two options to do so:
 - a. Buy Back You would be responsible to pay only the difference between your bid price and the current market price. Current market prices will be available on Friday of fair week.
 - b. Food Bank You would be responsible to pay the full price bid but you will be able to claim a tax benefit. You will be provided with a follow-up letter from the food bank via postal mail with a recognition letter along with receipt/proof of purchase for tax preparation purposes. We advise all donors to consult with their tax professional for additional advice. The fair will set up all hauling of animals bought for donation to the food bank.
- 4. If you would like to support the Youth and wish to keep the animal there is one option to do so:
 - a. Keep You would be responsible to pay the full price bid. You must have hauling set up prior to sale for removal of any livestock you purchase to keep. You are responsible for setting up any butchering if you desire to do so with purchased animal.
- 5. An animal may be donated to a nonprofit organization and resold one time only.
- 6. Animals may be removed from the fairgrounds anytime after completion of the sale and payment arrangements have been made. All animals must be removed by 9 AM Saturday.
- 7. Each exhibitor shall be responsible for their own entries. All exhibitors or their designee must be present when the livestock is sold.
- 8. The Fair Association will charge sellers a 3.2% commission.
- All animals are at the risk of the buyer when struck off, but courtesy will be given to protect their interest. The Fair Management acts as agent only and cannot assume responsibility for any animal in the auction.
- 10. All animals are sold by the head.
